 - The laser diode output is at 100% 60mw
 - The power density varies depending on the distance between the patient's head and the laser diode (1-10mm)
 - Laser power reduces by the inverse square law as distance grows
 - The light energy density from 1mm @ 0.85W/cm square & 10mm @ 0.08W/cm square

INITIAL TREATMENT PROTOCOL – Plan 1 & 2 Female/Male Hair Thinning, Alopecia* & Male Pattern Baldness





1. How does HairGrowth Therapeutics (HGT) work?

- HGT is a Class 2 Laser that uses Deep Low Level Laser Therapy (D3LT) also known as Photobiomodulation Therapy (PBM) to treat the head.
- Laser or LED light therapy enhances and stimulates tissue repair, reduces inflammation and pain wherever the beam is applied.
- > HGT effectiveness is based on the 1550nm wavelength the light energy density.
- The laser diode output is at 100% 60mw.
- The power density varies depending on the distance between the patient's head and the laser diode (1-10mm).
- Laser power reduces by the inverse square law as distance grows.
- > The light energy density from 1mm @ 0.85W/cm square & 10mm @ 0.08W/cm square.

2. How is HairGrowth Therapeutics (HGT) different from other Home use and Clinical equipment available?

➤ HGT as a Class 2 Laser offers safe proprietary wavelengths that administer Deep Low Level Laser treatments directed on the head. Our wavelengths deliver greater absorption and deeper penetration which promotes increased blood supply to the area treated. As a result, LaserStim is seeing long lasting growth and results in as little as 2 months, less time than typical products.

- 4. Qualifications Who can administer treatments?*
 - Licensed individuals in the aesthetics, clinical, therapeutic, and medical fields.
 - Licensed centers with medical director oversight and trained staff.
 - Check your individual state as requirements may vary.
- 5. Does the equipment need to be registered with my state of operation?
 - Class 2 Lasers do not typically require state registration
 - ➤ It is recommended that you check with your individual state online search "INSERT STATE NAME requirements for registering class 2 lasers"
- 6. Do client's medications impact the effectiveness of treatment?
 - It's important to note that every person and body differs. It is recommended to check with a physician if you have questions around your health and safety and contraindications that are specific to your past or current health and medical conditions, incidents and/or medications you may be taking.
 - Patients should speak to their doctor and review medications and inquire; "Do any of my medications preclude the treatment of Laser Stimulation for hair growth?"
- 7. Are there medical conditions, issues that or treatments that may impact use of HGT? Contraindications?
 - While this Class 2 Laser therapeutic treatment on the head is very safe and highly effective, it's important to note that every person and body differs. It is recommended to check with a physician if you have questions around your health and safety and contraindications that are specific to your past or current health and medical conditions, incidents and/or medications you may be taking. In particular, individuals with current conditions such as (and Not limited to) tumors, pregnancy, cancer, brain injury, open wounds, epilepsy should seek physician review prior to services.

8. Will I feel any pain during the treatment?

Under normal conditions a client should feel no discomfort during treatment. In some rare occasions, patients with heightened sensitivity to light on the head due to medications or other reasons can potentially experience some mild discomfort which typically disappears after the treatment. Should a client experience any discomfort the treatment should be immediately halted and the discomfort investigated.

9. Will heat be felt on the head during the treatment?

It's not unusual to feel gentle warmth. Heat or burning is not typical and should be addressed immediately with the therapist.

10. What's the youngest age a person can begin using this treatment?

- Not recommended for youth under 13 years of age.
- It is also recommended that the family physician is consulted.

11. How many treatments can I anticipate before seeing results?

Treatment results will vary with each client. Average treatment time is a minimum of three months with two treatments per week. Signs of growth can be anticipated during this time. Although some patients see results in less time, this is not typical. Consistency with treatment appointments is a key factor for success.

12. Will a client experience any "headaches" as a result of the treatment?

The treatments do not typically cause headaches. If client is prone to head aches or other medical conditions, their physician should be consulted prior to treatment.

13. Will this process evolve the hair out of hair follicle Telogen or resting phase?

Under most circumstances, stimulating the blood supply to hair follicles should release the follicles from the "resting phase."

14. Is it safe to look directly into the "helmet/cap" when the unit is in on and in "RUN" mode?

NO! Under no circumstance should anyone look directly at the inside of the "helmet/cap" when the unit is in the On and RUN mode. Looking directly at a laser diode can cause vision impairment.

15. What is the result of remaining under the helmet/cap longer than anticipated?

➤ All treatment sessions are set to RUN for 90 seconds and Rest for 240/4 minutes seconds 20 minutes in duration. After 20 minutes the unit buzzer will be activated indicating that the treatment has ended. Should a patient remain under the helmet longer that 20 minutes no harm will be caused. Once the hair follicles have been stimulated for the prescribed time no additional absorption will take place.
